## SCOPE AND CONTENT NOTE

Terry de la M. Allen commanded the 1<sup>st</sup> Infantry Division in North Africa and Sicily in World War II. Later he was commander of the 104<sup>th</sup> (Timberwolf) Infantry Division during operations in Belgium, Holland, the Rhineland campaign and subsequent campaigns until the end of the war in Europe.

The documents relate to Allen's military career during World War II and to the activities of the 1<sup>st</sup> and 104<sup>th</sup> Infantry Divisions. These documents include the following reports and publications: *A Factual Situation and Operations Report on the Combat Operations of the 1<sup>st</sup> Infantry Division During its Campaigns in N. Africa and Sicily During the Period 8 Nov. '42 to 7 Aug. '43* (a report written by Allen); *Night Attacks* (prepared from a lecture given by Allen); and *Directive for Offensive Combat*. Additional materials include newspaper clippings, awards, citations and commendations.

The original records were loaned to the Library for photocopying and were then returned to the donor. Twenty-one photographs were also copied and returned to the donor.
