The records of Thomas E. Stephens, Special Counsel and Appointments Secretary to President Eisenhower are made up of three distinct groups of documents: (1) the pre-accession which arrived with the first shipment of records to NLE in 1961, (2) A66-20 which was received May 5, 1966, and (3) A72-3 which was placed in the vault at some unknown time, probably at the time of the first shipment but no record of this can be found, and only recently removed and accessioned. These records are covered by the letter of gift from Dwight D. Eisenhower to Franklin Floete, dated April 13, 1960

By agreement with Dwight D. Eisenhower the following classes of documents will be withheld from research use:

1. Papers that are security-classified pursuant to law or Executive Order, until such classification shall be removed.
2. Papers the use of which may be prejudicial to the maintenance of good relations with foreign nations.
3. Papers containing statements made by or to the donor in confidence unless in the judgment of the Director of the Dwight D. Eisenhower Library the reason for the confidentiality no longer exists.
4. Papers relating to private business affairs of individuals and to family and personal affairs.
5. Papers containing statements about individuals which might be used to injure or harass them or members of their families.

## SCOPE AND CONTENT NOTE

The records of Thomas E. Stephens cover the period 1952-61 when Mr. Stephens was associated with Dwight D. Eisenhower, first in the 1952 Campaign as the General's appointments secretary and then during the Administration as Appointments Secretary and Special Counsel advising the President on political matters.

As was already mentioned, these records are broken down into three accessions. The pre-accession and accession A66-20 deal primarily with 1952 and 1956 campaign matters and the respective Inaugurations. Included in the 1952-53 material are: requests for appointments with DDE, information about convention delegates, information about the activities of the Republican National Committee, Citizens for Eisenhower, and other political organizations, and general correspondence handled by Mr. Stephens. The 1956-57 files contain approximately the same types of material but have a greater volume. There are approximately 18 boxes dealing with the 1956-57 period as compared to 10 boxes of 1952-53 material. There are five boxes dealing with the arrangements for the 1957 Inaugural, including responses to invitations. There is a four box trip file for the 1956 Campaign and approximately six boxes of correspondence and reports through which Mr. Stephens kept up with the political climate around the country in preparation for the 1956 Campaign. Mixed in with the 1955-56 correspondence received at his New York address are some personal items as well as political observations. There is also one box of anti-Eisenhower material, ordinarily labeled "scum", which gives a representative sample of the techniques used in the various smear campaigns against General Eisenhower. There are four 3x5 card index boxes which contain useful information about individuals: addresses, business affiliations, proper salutations, when DDE met the individual, and other notations. The names are arranged alphabetically or by state. Together the pre-accession and A66-20 make up approximately two-thirds of the total records.

The final one-third, A72-3, relates more closely to Mr. Stephens' position as Appointments Secretary in the White House. It is made up of one series covering the President's three overseas trips during 1959-60, consisting mainly of State Department telegrams making arrangements and other planning aspects of the trips, and one series of sheets listing the President's daily appointments. The appointment records are arranged chronologically from January 1953 through January, 1961, and appear to be drafts for the formal appointment books.

There are a few scattered items and short series which are not related to the campaigns, trips or appointments records. The McKinsey & Company Reports on Restaffing the Executive Branch of the Government and Eisenhower Foundation material are most important among these. They make up a very small portion of the total volume of the papers, however.

Folders for various stops on three overseas trips taken by President Eisenhower: Far East, June 1960 (Philippines, Alaska, Okinawa, Japan, Hawaii, Korea, Formosa), South America, February 1960 (Argentina, Puerto Rico, Brazil, Chile, Uruguay), and Europe and Middle East, December 1959 (Italy, Turkey, Greece, Spain, India, Morocco, Afghanistan). Includes many telegrams and memoranda making arrangements for the trips. The three trips are filed separately, but arrangements within each trip is random.

As there are many notations, additions, and corrections on the pages, these were probably draft copies of the formal appointment books. Arranged chronologically.

One folder on the President's trip, June 10-14, 1953 to Minnesota, North Dakota, South Dakota, New Hampshire, and New York. Two folders of old calendar committee sheets labeled "personal and confidential". One empty folder labeled "Old secret lists". No special arrangement.
